AXA Funds to adopt AMP branding

In March 2011, AMP and AXA merged to form the new AMP, Australia's leading independent wealth management company. As part of the merger, we have an obligation to stop using the AXA brand in the Australian market by the end of March 2013. This note is to update you on what we are doing to meet this obligation so you are aware of the changes and have time to make any necessary adjustments in your business.

12 November 2012 is brand changeover day

On 12 November we will change the AXA branding to AMP across most systems, PDSs, marketing brochures, fact sheet reporting and other items. Making the majority of changes on one day minimises the brand transition period for you and your investors, and it also means we are well ahead of our 31 March deadline.

As a consequence, the marketing name of the AXA Funds listed below will soon reflect AMP Capital branding. Other than this brand change, all Fund details remain the same.
